It focuses on planning and technique for conducting internal/external audits. Particular attention will be given to fulfilling HOKLAS criteria for identification of root causes, resolving non-conformities and monitoring of effectiveness of corrective actions. Emphasis is also given to technical requirements for different disciplines.

On completion of the course, participants shall have adequate knowledge in conducting internal audits and pre-extension audits.
