## **Guidelines for Counting Continuing Professional Development Unit (CPDU)**

(with effect from 1 May 2013)

Developer of content of a new approved courseware.	3 CPDUs per 1 hour courseware delivery
Board or committee member of testing organizations and/or government agencies  Note 3	20 CPDUs (board) per annum 10 CPDUs (committee) per annum
Working and sub-committee member of testing organizations and/or government agencies Note 3	2 CPDUs for each attendance of committee meeting, maximum 10 CPDUs per annum
Examiner of PCSTP	1 CPDU for interview of one candidate applying for certified testing professional
Contribution of examination questions for PCSTP scheme Note4	0.5 CPDU for multiple choice and short questions (including answers) 1 CPDU for long questions
Development of new international test standard	30 CPDUs
Method verification of accredited new international/regional test standard (limited to 2 developers for one method) Note5	10CPDUs
Development of accredited in-house method (limited to 2 developers for one in-house method) Note5	15 CPDUs
Technical visit	0.5 CPDU per each visit hour

The above guidelines for counting CPDUs are subjected to periodic review.

A **Certified Testing Technician (CTT)** must accrue a minimum of **30** Continuing Professional Development Units (CPDUs) during each three-year certification cycle by participating in any one or more activities as listed in the table above.

A **Certified Testing Professional (CTP)** must accrue a minimum of **60** Continuing Professional Development Units (CPDUs) during each three-year certification cycle by participating in at least two activities (maximum CPDUs gained of anyone activity is 30) as listed in the table above.

#### Explanatory notes:

#### ■ Note 1:

- a) The Certification Board of PCSTP reserves the right in decision of CPDUs gained of seminar, workshop and/or courses other than those organized by Hong Kong Association of Testing, Inspection and Certification Limited (HKTIC) or approved training providers. Refer to the website <a href="www.hktic.org">www.hktic.org</a> for lists of training courses and approved courses that CPDUs are counted.
- b) Candidates attending courses, workshop and/or seminar of similar topics could only gain CPDUs for one of these courses, workshop and/or seminar.

#### ■ Note 2:

- a) Gaining of CPDU from internal training applies only to Certified testing Technician (CTT).
- b) Internal training should be organized in similar structure as external training with training materials, assessment and attendance or assessment certificate.
- c) Pre-approval of number of CPDUs for an internal training course should be sought from the Certification Board of PCSTP prior to commencement of the course.
- Note 3: Testing organizations and government agencies refer to the Hong Kong Association of Testing, Inspection and Certification Limited (HKTIC), the Council of Testing and Certification (CTC), Qualification Framework (QF) and Hong Kong Accreditation Services (HKAS).
- Note 4: CPDUs will be granted subject to acceptance and approval of the questions by the Examination Board of PCSTP.
- Note 5: Accreditation should be granted by HKAS or accreditation body having MRA (mutual recognition agreement) with HKAS.
